



RICHARD KING MELLON

1899-1970

Richard King Mellon was born in Pittsburgh, Pennsylvania on June 19, 1899, the son of Richard Beatty Mellon and Jennie King Mellon. Mr. Mellon served his country in both World Wars and in peacetime, attaining the rank of Lieutenant General, United States Army Reserve, and receiving the Distinguished Service Medal. Mr. Mellon was the dominant figure in the financial, industrial, and civic life of his community for many years. He was President of Mellon National Bank and for twenty years Chairman of the Board of Mellon National Bank and Trust Company; as a director, he aided the growth of many of the nation's leading enterprises, particularly Gulf Oil Corporation and Aluminum Company of America.

Mr. Mellon, President and Governor of T. Mellon and Sons, inspired and led the rebirth of a great American city. His creative energies forged the Pittsburgh Renaissance, a nationally recognized architectural, civic, social, and educational venture.

In 1936, Mr. Mellon married the former Constance Mary Prosser, who served as Chairman of the Board of Trustees of the Richard King Mellon Foundation from its inception in 1947 until her death in 1980.

A renowned sportsman, Mr. Mellon generously endeavored to preserve the quality of the natural environment and to protect its wildlife.

Mr. Mellon died on June 3, 1970.

PRESIDENT'S LETTER

The Richard King Mellon Foundation is pleased to report that on July 1, 2005, six grandchildren of Richard King Mellon and Constance Prosser Mellon became trustees of the Foundation.

This new generation includes Alison M. Byers, Psy.D., and W. Russell G. Byers, Jr., the daughter and son of the late Constance Mellon Byers; Armour N. Mellon and Richard A. Mellon, the sons of Richard P. Mellon, the Foundation's

chairman; and Catharine Mellon Cathey and Constance Elizabeth Mellon Kapp, my daughters.

An additional significant transition in 2005 was the appointment of Scott D. Izzo as director of the Foundation, also effective July 1. He succeeds Michael Watson, who is now senior vice president.

Our transitions could be seen as a reflection of those taking place in Pittsburgh as the region builds on its strengths to attract and retain talented men and women who are shaping a vibrant, progressive future for this historic city on the rivers. The Foundation is proud to work with them and to support many of their ideas, hopes, and projects for an increasingly competitive southwestern Pennsylvania.

2005 Grant Highlights

In 2005 the trustees approved new grants totaling \$81,678,925, and the Foundation paid out \$74,300,889 toward its priorities: Conservation; Regional Economic Development; Children, Youth, and Young Adults; Education; and Human Services and Nonprofit Capacity Building. The trustees established these priorities effective January 1, 2005.

Conservation

The Foundation invested \$24,236,000 to protect, preserve, and restore green and natural infrastructure. As in the past, we formed key partnerships with public and private agencies to identify, acquire, and safeguard strategically targeted sites.

Working with The Conservation Fund, the Foundation engaged in one of the most important and innovative public-private conservation efforts of recent times by protecting over 1,000,000 acres of land in 2005—more than all the acreage protected during the 15 years of the Foundation's former American Land Conservation Program's existence. The transactions included nearly 900,000 acres of grazing rights leases on public lands stretching from the Grand Canyon's North Rim to the Utah border, shielding this wilderness from overuse.

In Pennsylvania the Foundation partners with such public agencies as the Department of Conservation and Natural Resources to protect land, streams, and watersheds.

Regional Economic Development

The competitive future of southwestern Pennsylvania, with a special concern for the health of its

urban core, is a longstanding Foundation priority. The trustees support endeavors to improve the quality of life, stimulate business and workforce development, and leverage the impact of the region's assets. Gifts in 2005 to the Pittsburgh Life Sciences Greenhouse and to the Idea Foundry, for example, assisted strategies to position southwestern Pennsylvania as a world leader in the life sciences and technology industries, and to help entrepreneurs transform business ideas into fundable start-ups.

The Tides Center received support for Venture Outdoors to promote recreation, while the Carnegie Institute is using a contribution of \$1,000,000 for *Fierce Friends: Artists and Animals, 1750–1900.* To leverage the regional tourism opportunities of this exhibition, the Foundation invited more than 70 diverse partners to innovate in celebrating area museums, theaters, sports teams, cultural destinations, and activities. The result is "Pittsburgh Roars," the impetus for an annual themed event to market the Pittsburgh region.

Children, Youth, and Young Adults

A \$1,000,000 gift toward the capital campaign for a new Children's Home of Pittsburgh was the major 2005 grant in this category. Enabling the home to double its total space, the new facility will also provide an economic boost to the historic neighborhood of Bloomfield–Garfield.

The Foundation assisted quality after-school programs as well as the award-winning Children's Museum of Pittsburgh for its multimedia *Studio* program. The Children's Museum has had an overarching impact on children's lives throughout southwestern Pennsylvania, and its renovation has significantly enhanced its North Side neighborhood.

Education

The Foundation has a longstanding commitment to the colleges and universities that attract talented students and faculty to southwestern Pennsylvania and also stimulate business development. Significant gifts in 2005 included support for a capital campaign at Duquesne University and for the second phase of a renovation project at Point Park University.

Additionally, the trustees approved gifts for high-quality early childhood education and built on the Foundation's decades-long commitment to educational opportunities for minorities.

Human Services and Nonprofit Capacity Building

The Foundation supports human service organizations through key intermediary organizations as well as a select number of critical and strategic service providers. For instance, a grant of \$1,500,000 to the Allegheny County Department

of Human Services will match HUD funding to meet urgent housing needs for the homeless, disabled, and other vulnerable populations.

To enhance operating efficiencies of nonprofits, the trustees have encouraged and facilitated resource sharing. One example in 2005 is support to Wesley Institute in its successful merger with Spectrum Family Network. A number of grants, too, will help build the capacity of nonprofits to better ensure their long-term sustainability.

Hurricane Katrina Relief Initiatives

Following the devastation caused by Hurricane Katrina in August 2005, the Foundation began working to identify specific, continuing initiatives to assist with Gulf Coast recovery. Having discussed in 2005 how they might target support most effectively, the trustees subsequently approved in 2006 a contribution of \$1,000,000 to the Baton Rouge Community Foundation. In addition, animal protection organizations received assistance for rescue and relief efforts.

As a new generation enters into the work of the Richard King Mellon Foundation, we look forward to building on the Foundation's continuity of giving "in the public interest." We are grateful for the privilege of being able to join with public and private partners to help create new opportunities for our extended communities.

The following sections provide brief reports on the Richard King Mellon Foundation's grant activities in 2005, as well as descriptions of the organizations the Foundation has assisted.



CONSERVATION

American Rivers *Washington, DC*

American Rivers is a national nonprofit conservation organization dedicated to protecting and restoring healthy natural rivers and the variety of life they sustain for people, fish, and wildlife.

\$200,000 for two-year program support toward removing dams in Pennsylvania.

Bobwhite Brigade

San Antonio, Texas

The brigade strives to empower high school students with the necessary skills and knowledge in wildlife and habitat conservation, land stewardship, team building, communication, and leadership to become ambassadors for conservation in order to ensure a sustained wildlife legacy for future generations.

\$200,000 payable as a challenge grant toward operating support.

Carnegie Institute

Pittsburgh, Pennsylvania

Founded in 1956, Powdermill Nature Reserve is a biological research and educational field station of the Carnegie Museum of Natural History.

\$3,000,000 payable partially as a challenge grant toward renovations and expansion of Powdermill Nature Reserve.

Community Foundation of Greater Johnstown

Johnstown, Pennsylvania

The purpose of the Western Pennsylvania Watershed Protection Program is to protect or restore Pennsylvania's unique water resources on an ecosystem basis and to foster separate technologies used to preserve and reclaim watersheds.

\$750,000 payable over two years, through the Community Foundation of Greater Johnstown, to support the Western Pennsylvania Watershed Protection Program.

The Conservation Fund Arlington, Virginia

The Conservation Fund is a national conservation organization that works in partnership with businesses, government, and other nonprofits to protect America's most important landscapes and waterways, and to develop creative solutions to conservation problems, demonstrating that ecologically sound land use and economic return can be compatible.

\$7,765,000 toward land purchase and easements.

\$3,500,000 toward acquisition and preservation of the Laurel Hill property in Cambria County, Pennsylvania.

\$2,200,000 to acquire and hold land for the Zoological Society of Pittsburgh intended to be developed into an International Conservation Center in Somerset County, Pennsylvania.

\$1,175,000 toward acquisition and preservation of the Laurel Fields property in Clear Creek State Forest, Pennsylvania.

The Horticultural Society of Western Pennsylvania

Pittsburgh, Pennsylvania

The society's purpose is to develop the region's first comprehensive botanical garden to focus on displays of regional flora, horticultural and environmental education, and research into botanical issues of regional importance.

\$250,000 toward planning and operations in development of The Botanic Garden of Western Pennsylvania.

Hubbs-SeaWorld Research Institute

Orlando, Florida

Hubbs-SeaWorld Research Institute is a public, nonprofit charity dedicated to providing effective solutions to conflicts that arise between human activity and the natural world. Hubbs-SeaWorld scientists apply sophisticated technologies to seek the solutions that protect and conserve marine animals while benefiting humans and their reliance on marine resources.

\$190,000 toward hurricane damage repairs to sea turtle nesting research facility.

Loyalhanna Watershed Association, Inc.

Ligonier, Pennsylvania

The association's mission is to conserve, protect, preserve, and restore the water, land, and other resources of the Loyalhanna Creek Watershed in order to perpetuate and enhance the region's quality of life.

\$80,000 toward two years of operating support.

\$50,000 to construct a paved walkway through St. Clair Park in Ligonier Borough.

Mountain Watershed Association, Inc.

Melcroft, Pennsylvania

The Mountain Watershed Association works to address land- and water-related issues that affect the Indian Creek Watershed along Route 381 in the Jones Mills area.

\$150,000 payable over two years to support the Indian Creek Comprehensive Restoration Project.

National Park Foundation Washington, DC

The National Park Foundation works collaboratively with the National Park Service and key partners to support a multidimensional web of opportunities for people from all backgrounds, ages, and regions to connect with their national parks through personally meaningful experiences. Since its establishment, the National Park Foundation has helped to fund important conservation, preservation, and education efforts.

\$500,000 toward construction of the Flight 93 National Memorial in Somerset County, Pennsylvania.

Northside Leadership Conference

Pittsburgh, Pennsylvania

The conference is a coalition of North Side community-based organizations, committed to addressing mutual concerns through a united approach in order to promote and enhance the vitality, quality of life, and image of Pittsburgh's North Side.

\$150,000 to support the Allegheny Commons Pilot Project, part of a master plan for one of the region's most significant parks.

PA CleanWays of Allegheny County

Pittsburgh, Pennsylvania

PA CleanWays of Allegheny County is an independent chapter of PA CleanWays, a nonprofit volunteer organization whose goal is to protect, restore, and maintain environmental and scenic qualities of our roadways, waterways, pathways, and other areas. The organization empowers people to eliminate illegal dumping and littering in Pennsylvania.

\$30,000 toward operating support.

Pennsylvania Environmental Council, Inc.

Pittsburgh, Pennsylvania

The Pennsylvania Environmental Council was established to promote wise stewardship and rational use of the land, air, water, and other natural resources, as well as to protect and conserve urban and rural amenities.

\$415,000 to support the Ohio Headwaters Initiative.

\$21,000 for the Lake Erie Region Conservancy's easement acquisition along the Lake Erie shoreline.

Pheasants Forever

St. Paul. Minnesota

Pheasants Forever is dedicated to the protection and enhancement of pheasant and other wildlife populations in North America through habitat improvement, land management, public awareness, and education.

\$10,000 to trap and transfer ringnecked pheasants from South Dakota to the Pike Run Watershed in Fayette County, Pennsylvania.

Phipps Conservatory, Inc.

Pittsburgh, Pennsylvania

Phipps Conservatory and Botanical Gardens' mission is to promote awareness of plants and their diverse interactions with mankind.

\$112,000 to support renovations in Mellon Park.

Pinchot Institute for Conservation

Washington, DC

The Pinchot Institute for Conservation is a forest conservation nonprofit specializing in sustainable forestry initiatives. The institute's mission is to promote leadership in conservation thought, policy, and action.

\$139,000 toward analysis of state deer management policies, including recommendations for deer and ecosystem management in Pennsylvania.

Pittsburgh Community Broadcasting Corporation Pittsburgh, Pennsylvania

WYEP Pittsburgh is an independent and innovative, listener-supported public media organization. It gives voice to quality music and provocative ideas, fostering an increasingly more vibrant, artistic, diverse, and caring community.

\$25,000 toward a series on game management in Pennsylvania focused on white-tailed deer.

Quebec-Labrador Foundation, Inc.

Ipswich, Massachusetts

The foundation was incorporated in both the United States and Canada to support the rural communities and environments of northern New England and the eastern Canadian provinces, and to create models for stewardship of natural resources and cultural heritage that can be applied regionally and worldwide.

\$100,000 to support programming and operations in the United States.

Rocky Mountain Elk Foundation

Missoula, Montana

The mission of the Rocky Mountain Elk Foundation is to ensure the future of elk, other wildlife, and their habitats.

\$504,000 toward the preservation of property in the Pennsylvania Wilds.

Tides Center/ Western Pennsylvania

Pittsburgh, Pennsylvania

Tides Center offers unique opportunities for emerging and existing charitable activities by providing a solid infrastructure for groups working to promote progressive social change on a local, national, and international level.

\$400,000 to support Sustainable Pittsburgh's 2006 Smart Growth and community renewal programming.

University of Pittsburgh at Greensburg

Greensburg, Pennsylvania

Smart Growth Partnership of Westmoreland County's mission is to improve the quality of growth through cooperative land use strategies in Westmoreland County. Its efforts enable communities to meet the challenges associated with growth and revitalization.

\$200,000 payable over two years to support the Smart Growth Partnership of Westmoreland County.

Western Pennsylvania Conservancy

Pittsburgh, Pennsylvania

The conservancy is dedicated to saving the places people care about by conserving water, land, and life through the permanent protection of the region's places of exceptional ecological, recreational, and scenic

\$120,000 for two-year support of the Ligonier Valley Easement Program.

Zoological Society of Pittsburgh

Pittsburgh, Pennsylvania

The zoo is dedicated to being a leader in and significant contributor to the conservation of endangered and threatened species. It provides an enjoyable family experience that fosters understanding, respect, and appreciation for wildlife.

\$2,000,000 toward a capital campaign for "Water's Edge," a new exhibit of polar bears, walruses, and sea otters, and for a state-of-the-art Animal Health Care Center.

REGIONAL ECONOMIC DEVELOPMENT

Action for Animals Latrobe, Pennsylvania

Founded in 1983, Action for Animals provides shelter and care for abused, abandoned, and stray dogs and cats of Westmoreland County. They adopt animals into responsible homes and vigorously promote spaying and neutering of all pets to eliminate the cruelty of animal overpopulation.

\$200,000 payable partially as a matching grant toward building renovations and program expansion.

Allegheny Conference on Community Development Pittsburgh, Pennsylvania

The conference is a private, nonprofit organization with the unique ability to convene corporate, government, and community leaders to frame, discuss, and implement civic initiatives in southwestern Pennsylvania.

\$390,000 as annual support for *3 Rivers: One Future*, a regional growth initiative.

Butler Economic Development Corporation

Butler, Pennsylvania

Butler Economic Development Corporation is a speculative building development organization that works in cooperation with Butler Community Development Corporation to assess and meet the community's building needs.

\$300,000 toward development of an agribusiness incubator.

Carnegie Institute

Pittsburgh, Pennsylvania

The Carnegie Institute is a collection of four distinctive museums: Carnegie Museum of Art, Carnegie Museum of Natural History, Carnegie Science Center, and The Andy Warhol Museum. During 2006, the Museums of Art and Natural History are collaborating to produce a major exhibit representing the core of a series of themed promotional events for the region.

\$1,000,000 to support the development, management, and marketing of the exhibit *Fierce Friends: Artists and Animals, 1750–1900*, primarily through expanded regional tourism opportunities utilizing the unifying theme of "Pittsburgh Roars."

Carnegie Mellon University Pittsburgh, Pennsylvania

Carnegie Mellon University is a private educational and research institution that builds on its tradition of innovation and transcends disciplinary boundaries to meet the changing needs of society.

\$300,000 to support the Red Team's driverless vehicle program.

Chartiers Valley Partnership, Inc.

Carnegie, Pennsylvania

The partnership's mission is to restore the Andrew Carnegie Free Library & Music Hall (Library) building to a fully functional and accessible library and cultural center serving the municipalities in the corridor between Pittsburgh and the Greater Pittsburgh International Airport.

\$500,000 to support a capital campaign to restore and revitalize the Andrew Carnegie Free Library & Music Hall facility.

Community Loan Fund of Southwestern Pennsylvania, Inc. Pittsburgh, Pennsylvania

Community Loan Fund provides capital to businesses in western Pennsylvania to have an impact in the region and to encourage entrepreneurship.

\$750,000 to support a loan fund for Propel Schools' facilities and for small business loans.

\$25,000 to support a pilot project on divestment of real estate by nonprofit organizations.

Cook Township

Stahlstown, Pennsylvania

The Cook Township Community Center provides recreational and social activities to the people in the township and surrounding area.

\$150,000 for expansion of the Community Center.

County of Allegheny Pittsburgh, Pennsylvania

The Department of Economic Development is managed by the Redevelopment Authority of Allegheny County and administers the county's \$50,000,000 low-interest revolving loan fund that was established in 1995 to create and retain jobs in the region.

\$500,000 to establish a business assistance fund to help reestablish small businesses that sustained flood damage from Hurricane Ivan.

Creative Nonfiction Foundation Pittsburgh, Pennsylvania

Founded in 1993, the Creative Nonfiction Foundation nurtures and stimulates nonfiction writing as a literary genre, and highlights Pittsburgh's broader literary cultures.

\$15,000 to support a nonfiction literary conference scheduled for November 2005.

The Downtown Management Organization

Pittsburgh, Pennsylvania

The mission of the Downtown Management Organization is to foster a clean, safe, accessible, and vibrant Downtown through a wide range of strategies. Its mission is achieved through partnerships with businesses, property owners, and other organizations, and through advocacy for action that will strengthen Downtown and enhance its beauty and vitality.

\$130,000 toward operating support and consulting fees related to redevelopment of Downtown Pittsburgh.

Duquesne University of the Holy Ghost **Institute for Economic Transformation**

Pittsburgh, Pennsylvania

The Institute for Economic Transformation organizes collaborative initiatives among university, industry, and community sectors to improve the economic performance of southwestern Pennsylvania by strengthening the global competitive advantages of its industrial base.

\$140,000 to support the Pittsburgh Regional Internship Collaborative Enterprise (PRICE), designed to engage Pittsburgh's financial services companies in a formal collaborative for talent pipeline development through internships, resulting in retention and workforce and economic development, with special emphasis on diversity and special labor pools.

The Eye & Ear Foundation of Pittsburgh

Pittsburgh, Pennsylvania

The Eye and Ear Foundation is the supporting organization whose purpose is to provide funds for the reasearch-related activities of the Department of Ophthalmology and Otolaryngology at the University of Pittsburgh/UPMC.

\$300,000 for the Joseph F. Novak Chair in Ophthalmology Research.

Fay-Penn Economic Development Council

Uniontown, Pennsylvania

The council is a membership organization that was formed to assist in the economic revitalization efforts of Fayette County.

\$250,000 toward operating support.

Fort Ligonier Association

Ligonier, Pennsylvania

The Fort Ligonier Assocation is chartered to collect, preserve, research, exhibit, interpret, and advocate the history and material culture of the 1758-1766 British-American fort and settlement.

\$350,000 toward the purchase of land adjacent to the Fort Ligonier property.

\$180,000 to acquire a portrait for the museum by artist Rembrandt Peale, depicting young George Washington.

The Frick Art & Historical Center Pittsburgh, Pennsylvania

The Frick Art & Historical Center combines in one place a 19th-century historic house and a museum of fine art. The five-acre complex also includes a glass greenhouse, car and carriage museum, visitors' center, and an award-winning café.

\$50,000 to support an exhibition titled *To Observe and Imagine: British Drawings and Watercolors, 1600–1900.*

Greater Pittsburgh Convention & Visitors Bureau Education Foundation, Inc. Pittsburgh, Pennsylvania

The bureau's Tourism and Cultural Heritage Department markets southwestern Pennsylvania and its cultural and heritage attractions and events to the individual consumer, as well as to group tour industries.

\$340,000 toward operating support for the Tourism and Cultural Heritage Department.

The Homewood Cemetery Historical Fund

Pittsburgh, Pennsylvania

The Homewood Cemetery Historical Fund was established to solicit funds needed for the preservation and restoration of the history and architecture of the Homewood Cemetery.

\$500,000 toward a capital campaign to restore and repair historical buildings and/or landscape.

Idea Foundry

Pittsburgh, Pennsylvania

The Idea Foundry is a western Pennsylvania initiative of universities, private foundations, industry, government, and venture capitalists collectively stimulating innovation, new company creation, and job growth.

\$1,000,000 toward operating support for 2005/2006.

Latrobe Area Hospital Charitable Foundation

Latrobe, Pennsylvania

The Latrobe Area Hospital Charitable Foundation was founded in 1995 to support Latrobe Area Hospital's mission of meeting the health care needs of the community.

\$1,000,000 to support a capital campaign for new emergency department facilities.

Lawrenceville Corporation

Pittsburgh, Pennsylvania

The Lawrenceville Corporation is a catalyst and conduit for reinvestment in the Lawrenceville community. It develops commercial and residential real estate, provides technical assistance to local businesses, facilitates strategic community planning efforts, and markets the neighborhood's commercial districts and the local design industry cluster.

\$150,000 to help purchase and buildout the Blackbird Artist Studios, where artists and designers will produce and sell their work.



The Blackbird Artist Studios is a new, green center offering affordable studio and retail space to professional visual artists. Artists and designers are energizing Blackbird's 19th-century neighborhood.

Ligonier Valley Rail Road Association

Ligonier, Pennsylvania

The association was formed to preserve the legacy of the Ligonier Valley Rail Road.

\$214,000 to stabilize the exterior of the Darlington Station.

Duquesne University is committed to excellence in liberal and professional education, maintains a profound concern for moral and spiritual values, and provides services to the church and local community.

\$2,000,000 toward a capital campaign, payable over two years.

Education Delivery Systems, Inc. *Pittsburgh, Pennsylvania*

Education Delivery Systems (EDSYS) was formed in 2000 to launch the new City Charter High School. The school's mission is to graduate young adults who are prepared academically, technically, personally, and socially to participate and succeed in post-secondary education and/or employment in technology-related fields.

\$180,000 toward expansion of City Charter High School.

Family Tyes, Inc.

Pittsburgh, Pennsylvania

Family Tyes seeks to organize programs and activities to provide lifelong positive alternatives to negative influences by utilizing a shared interest in fly fishing to promote family values, mentors, the educational process, and business skills. They encourage young people to dream and teach them to believe in the American system.

\$580,000 to create a sustainable conservation education program, payable over three years.

Grantmakers of Western Pennsylvania

Pittsburgh, Pennsylvania

Grantmakers is a professional society of member grant-making organizations dedicated to promoting effective philanthropy in western Pennsylvania.

\$19,425 toward annual operating support.



Keystone Oaks High School Pittsburgh, Pennsylvania

Project Succeed at Keystone Oaks High School is an alternative evening study program for those persons who, regardless of age, have dropped out of school. The program helps them to achieve a high school diploma.

\$20,000 toward two years of program support for Project Succeed.

The Kiskiminetas Springs School Saltsburg, Pennsylvania

The Kiski School is an all-male, independent boarding school in southwestern Pennsylvania designed to prepare young men to succeed in college.

\$500,000 toward a capital campaign for renovations and programming initiatives.

The school is a private, independent school located in southwestern Pennsylvania serving children in kindergarten through 12th grade.

\$50,000 to upgrade playground equipment and resurface the parking lot and driveway.

\$300,000 toward a professional development program to inspire and enhance history education.

Negro Educational Emergency Drive

\$200,000 toward scholarship support for African-American students.

\$900,000 toward a capital campaign to renovate Rowe Hall, including application for LEED certification.

Somerset County Campus Foundation for Allegany College of Maryland

Somerset, Pennsylvania

The Somerset County Campus for Allegany Community College of Maryland is the only source of postsecondary education that exists in Somerset County, Pennsylvania.

\$150,000 to help expand the Somerset County Campus academic facility.

St. David Society of Pittsburgh Pittsburgh, Pennsylvania

The Welsh fellowship in southwestern Pennsylvania, Ohio, and West Virginia has begun a major effort to make a lasting witness to its history and heritage in this part of Pittsburgh. Each year since 1914, the Mellon Lecture Program has enabled the School of Medicine to invite eminent investigators and clinicians in the medical sciences to share their knowledge with their peers in Pittsburgh.

\$490,000 toward the development of a Faculty Resource Center.

Waldorf School of Pittsburgh

Pittsburgh, Pennsylvania

The Waldorf School is founded on the concept of educating the whole child, which includes traditional academics as well as the personal growth that comes from experiential learning. It also seeks to engage families in education to create learning partnerships.

\$300,000 payable as a matching grant toward exterior restoration and repair.

Waynesburg College

Waynesburg, Pennsylvania

Waynesburg College is the primary higher educational institution in Greene County. It serves the people, organizations, and communities of the area through innovative academic programs, expert technical assistance and training for businesses, and an extensive commitment to volunteer service.

\$400,000 to support a new Center for Research and Economic Development.

Westmoreland County Community College Education Foundation

Youngwood, Pennsylvania

The foundation is the fund-raising arm of the college, which is a two-year institution located near Greensburg, Pennsylvania, dedicated to providing an affordable education to the residents of the region.

\$500,000 to support a capital campaign.

Word of God Catholic School

Pittsburgh, Pennsylvania

Word of God is a Roman Catholic elementary school that offers exceptional academic and spiritual instruction in small class settings.

\$27,000 to help replace and upgrade the school's entrances.

Total Education \$13,556,425

Allegheny County Department of Human Services

Pittsburgh, Pennsylvania

\$100,000 to support a sustainable greenhouse project.

Caregivers Institute, Inc.

Pittsburgh, Pennsylvania

The institute's mission is to improve the health and vocational longevity of direct caregivers through prevention and intervention services that include peer support, education, personal growth, spiritual retreat, recreation, and community building activities.

\$100,000 payable over two years to pilot a Caregivers Institute.

Owned and operated by the Apostles of the Sacred Heart of Jesus, Clelian Heights is a private educational, residential, and training facility for children and adults ages three to 50 and beyond, with mental retardation and other developmental disabilities.

\$97,000 toward building renovations.

Duquesne University of the Holy Ghost **Nonprofit Leadership Institute** Pittsburgh, Pennsylvania

Established in 1996 to inspire excellence in nonprofit governance, the Nonprofit Leadership Institute is housed in the School of Leadership and Professional Advancement and is supported by grants from local foundations and by registration fees from program participants.

\$300,000 as a capacity-building grant, payable over two years to expand the New Trustees for a New Pittsburgh initiative.

East Liberty Family Health Care Center

Pittsburgh, Pennsylvania

Founded in 1982 as a faith-based health care provider, the center is dedicated to serving those residents in poor communities in Pittsburgh's East End. Through five locations it helps address the needs of the homeless and alcohol and drug addicted, and offers pediatric and prenatal services through outreach in the community.

\$125,000 payable as a matching grant toward restoring the center's operating reserves.

Family Resources

Pittsburgh, Pennsylvania

Family Resources is a private, nonprofit organization whose mission is to prevent and treat child abuse by strengthening families and neighborhoods.

\$750,000 toward a capital campaign for renovations to the Family Retreat Center.

Jewish Healthcare Foundation

Pittsburgh, Pennsylvania

The Working Hearts initiative is a coalition of more than 70 community organizations, seeded by the Jewish Healthcare Foundation, that functions as an education and communications network to improve heart health.

\$20,000 to support the 2006 Working Hearts Campaign designed to raise risk-awareness of heart disease.

Manchester Craftsmen's Guild Pittsburgh, Pennsylvania

Manchester Craftsmen's Guild is a multidisciplinary center for arts and learning that employs the visual and performing arts to foster a sense of accomplishment and hope in the urban community.

\$200,000 as a capacity-building grant to support the income generating and archiving components of MCG Jazz, a social enterprise.

North Side Christian Health Center Pittsburgh, Pennsylvania

The center was founded in 1995 and provides "whole-person" health care services to medically underserved people from Pittsburgh's North Side and neighboring communities.

\$125,000 toward operating support and a business plan for expansion.

Onala Club

Pittsburgh, Pennsylvania

Onala Club provides an environment that fosters an atmosphere of recovery from the disease of addiction.

\$75,000 as a capacity-building grant to support facility renovations and build staff capacity.

Pittsburgh Pastoral Institute Pittsburgh, Pennsylvania

The mission of Good Grief Center for Bereavement Support is to be a resource center and safe place where all who have experienced the pain of death may come to work through loss and learn to manage grief.

\$100,000 as a capacity-building grant to provide marketing support for the social enterprise project of the Good Grief Center.

Pittsburgh Urban Leadership Service Experience

Pittsburgh, Pennsylvania

Pittsburgh Urban Leadership Service Experience (PULSE) is the inaugural program of the Mennonite Urban Corps. Providence Family Support Center offers a continuum of support services to women who are single heads of households, and their children, by linking with agencies and programs that provide economic, mental health, advocacy, and empowerment opportunities.

\$100,000 to support capacity-building initiatives.

Sisters Place

Clairton, Pennsylvania

Sisters Place is a supportive housing community committed to assisting single-parent families who are homeless toward self-sufficiency and family stability.

\$100,000 toward two years to help meet the federal match requirement for supportive services.

Society of St. Vincent de Paul Pittsburgh, Pennsylvania

The Society of St. Vincent de Paul offers tangible assistance to those in need on a person-to-person basis through such services as intervention, consultation, and often through direct dollar or in-kind service while conscientiously maintaining the confidentiality and dignity of those who are served.

\$10,000 to support a collaboration among thrift stores in the region.

United Way of Allegheny County

Pittsburgh, Pennsylvania

United Way's mission is to serve as a catalyst to improve the quality of life by mobilizing citizens to contribute the human and financial resources to nurture children and youth, strengthen families, support older people, promote health and wellness, and increase self-sufficiency.

\$550,000 to support the annual campaign.

United Way of Westmoreland County Greensburg, Pennsylvania

The United Way of Westmoreland County improves people's lives by mobilizing the caring power of communities. The service area extends throughout most of Westmoreland County, the Kiski area of Armstrong County, and the Connellsville area of Fayette County.

\$900,000 payable over three years toward the development of early child-hood care and after-school programs, and for other human service needs throughout the county.

Wesley Institute *Pittsburgh, Pennsylvania*

The mission of Wesley Institute is to create an environment in which children and youth are able to build the lifelong skills essential to become independent, responsible, contributing, and caring members of our community.

\$750,000 to support a successful merger with Spectrum Family Network.

Women's Center & Shelter of Greater Pittsburgh

Pittsburgh, Pennsylvania

The Women's Center & Shelter of Greater Pittsburgh provides a variety of services designed to end intimate partner violence in the lives of women and children. In addition to shelter, these services include counseling for resident and nonresident women, counseling for children, legal and medical advocacy, and education.

\$150,000 to help implement business systems for more effective service delivery, payable equally over three years.

\$75,000 to support rebuilding of local animal welfare groups affected by Hurricane Katrina.

Humane Society of Boulder Valley

Boulder, Colorado

It is the mission of the Humane Society of Boulder Valley to protect and enhance the lives of companion animals by promoting healthy relationships between pets and people.

\$10,000 to help offset animal rescue costs associated with Hurricane Katrina.

Noah's Wish, Inc.

Placerville, California

The sole mission of Noah's Wish is to rescue and shelter animals during disasters. It provides free services to disaster victims and their animals, animal organizations, and other disaster relief agencies.

\$75,000 to rebuild the Slidell Animal Shelter and help offset other costs associated with Hurricane Katrina.

NOTES TO FINANCIAL STATEMENTS

NOTE 1—Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Richard King Mellon Foundation (Foundation) are prepared on the accrual basis of accounting.

Nature of Operations

The purpose of the Foundation is to provide grants to organizations in Pittsburgh and Southwestern Pennsylvania, primarily in the areas of Regional Economic Development, Education, Children, Youth, and Young Adults, and Human Services and Nonprofit Capacity Building. Its interest in the area of Conservation is national.

Cash

Cash includes operating accounts plus domestic income cash held in bank custody accounts.

Investments

For financial reporting purposes, investments are stated primarily at market quotations which may not necessarily represent realizable values. Market quotations of foreign investments include the effect of the conversion into U.S. dollars at the foreign currency exchange rate in effect at year-end. Investments for which market quotations are not available are stated at estimated values as determined by investment managers. The book value of direct investments shown on the summary of investments is cost, except for donated assets which are valued at the market quotations at the date of receipt by the Foundation. Investments in alternative investments are valued at fair market value as determined in good faith by the general partner.

The Foundation's investments are exposed to various risks, such as interest rate, market, and credit. Due to the level of risk associated with investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that significant changes in risks in the near term may materially affect the amounts reported in the financial statements.

Realized gain (loss) from dispositions of investments is determined by specific cost identification. Unrealized appreciation (depreciation) of investments represents the change in the difference between market quotations and the total book value of investments held at the beginning and end of the year.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and the disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Reclassifications

Certain reclassifications of the 2004 financial statements have been made to conform to the 2005 classifications. These changes had no impact on previously reported results.

NOTE 2—Federal Excise Taxes

The Foundation is exempt from federal income taxes under Section 501(c)(3) of the Internal Revenue Code. The Foundation is subject to a federal excise tax equal to two percent of net investment income, which consists of interest and dividend income, realized gains on sales of investments less realized losses to the extent that they can be offset against realized gains, less related investment expenses. The Foundation met certain distribution requirements defined in Section 4940 of the Internal Revenue Code, resulting in a reduced tax of one percent of net investment income for the year ended December 31, 2004. For the year ended December 31, 2005, the Foundation provided for federal excise tax of two percent.

At December 31, 2005, deferred federal excise taxes are provided at one percent, which is the rate expected to be paid on unrealized gains on investments.

NOTE 3 — Commitments

The Foundation is a Limited Partner in several limited partnerships for investment purposes. At December 31, 2005 and 2004, the Foundation had contractually committed to additional investments of \$146,794,000 and \$122,312,000, respectively.

At December 31, 2005 and 2004, the Foundation subscribed to purchase fixed income obligations with an issuance date of January 2006 and 2005, respectively. The obligations totaled \$39,624,000 and \$16,471,000 at December 31, 2005 and 2004, respectively.

At December 31, 2005 and 2004, the Foundation subscribed to sell fixed income obligations with an issuance date of January 2006 and 2005, respectively. The obligations totaled \$28,707,000 and \$21,182,000 at December 31, 2005 and 2004, respectively.

Such information has been subjected to the auditing procedures applied in the audits of the basic financial statements and, in our opinion, is fairly stated in all material respects in relation to the basic financial statements taken as a whole.
